

## ESIC

Payroll data showed enrolments rose to 15.52 lakh in March against 14.92 lakh in February this year. And 67.59 lakh new members joined social security schemes run by EPFO during the seven-month period ending March 2018. The central government fund body has also been releasing payroll data from February 2018, covering the period from September 2017. EPFO in its latest data did not provide monthly new enrolments for March 2018. The CSO said the report released on Friday gives different perspectives on the level of employment in the formal sector and does not measure employment at a holistic level.
