JNU prof sacked: **Teachers' body** writes to Prez for VC's removal

New Delhi: The Jawaharla Nehru University Teachers Association (JNUTA) on Monday wrote to President Droupadi Murmu, the Visitor of the university, seeking the removal of Vice Chancellor Santishree Dhulipudi Pandit and annulment of the termination order against a probationary faculty member, terming decision "illegal."

According to university sources, the matter was placed before the Executive Council (EC) in its recent meeting, where it was decided to sack the faculty member.

The minutes recorded that the probationer had been on unauthorised leave for 51 days, in violation of service rules, and his performance was found unsatisfactory.

"The probationer accept ed his mistake in writing. What is wrong in taking ac tion against wrongdoing?" a senior official said, adding the decision was in line with service conditions governing probationary appointments.

The JNUTA, however, has challenged the action, telling the President that it reflects a "tipping point" in what it described as the VC's steady undermining of statutory processes and concentration of power. "The Vice Chancellor in dismissing from service a young faculty member of the University without there be ing any due cause for such action and without any due process being followed," it alleged. PTI

Bhubaneswar: At least one person was killed and 14 others were injured in separate incidents of clashes during processions for Ganesh idol immersion in Odisha, police said on Monday.

Immigration & Foreigners Act comes into force from Sept 1

Govt Now Has Powers To Restrict Entry, Put Curbs On Their Movement

TIMES NEWS NETWORK

New Delhi: Any foreigner who enters India without a valid passport or visa will henceforth invite a jail term of up to five years and a fine of up to Rs 5 lakh. In case such entry, stay or exit takes place on the basis of a forged passport or travel document, the imprisonment term will range from two years to seven years and the fine, from Rs 1 lakh to Rs 10 lakh.

These provisions of the Immigration and Foreigners Act, 2025 — passed by Parliament in the Budget session this year — took effect on Monday, with the Centre noti-

fying Sept 1, 2025, as the appointed day for the Act to come into force.

The Immigration and Foreigners Act repealed four separate Acts — the Foreigners Act, 1946; Passport Act, 1920;

Registration of Foreigners Act, 1939; and the Immigration, 2000 — which had overlapping provisions on related subjects of immigration and foreigners and consolidated them into a single, comprehensive legislation.

The new Act requires all higher educational institutions and universities to share information on any foreigner admitted by them, with the registration officer specified for such category of foreigners. This provision will also apply to all hospitals, nursing homes and other medical institutions with lodging facilities.

The Central govt now has

powers to restrict the entry of a foreigner or class of foreigners, not allow them to depart from India, enter a specified area, make them exit from India at their own cost, impose restriction on their movement, require them to furnish proof of identity, ensure their photograph and biometrics are taken and prohibit them from engaging in activities of

a specified description. Any foreigner overstaying their visa or violating conditions of the visa, or accessing a prohibited or restricted area, is proposed under the Bill to be punished with up to three years in jail or fine up to Rs3lakh, or both.
